Dear Parents.

"Greetings from GNIOT Group of Institutions !"

In view of present scenario and future uncertainty as COVID-19 pandemic altered our lives, the higher technical education are also given the flexibility to adapt and implement/ modify the way of teaching for the best interest of student, and we must act, keeping in mind your safety, and in accordance with the Government of India directives in this regard. In the last semester during the lockdown period, GNIOT has successfully conducted online classes, online test, online training, webinar and other activities for all courses.

For the upcoming semester, we have decided to continue with online classes till further directive of Government of India to prevent the academic loss of our beloved students. Therefore, you are informed to note the following :

- Online classes will resume from first week of August, 2020 for the ODD semester (2020-21) as (i) recommended by respective departments.
- To attend online classes, students need to register for Odd Semester, Session : 2020-21. The registration (ii)process for the upcoming session is going to start from 20th July, 2020. All students are hereby advised to complete registration process by paying their fee on or before **30th July, 2020**.
- Academic registration process (iii)
 - (a) Once you pay the fees you have to share your transaction details by submitting Academic Registration Form 2020-21 through the link available in institute student ERP login (details of Institute ERP login and Password alongwith link is shared separately through sms).
 - (b) After attachment of transaction details, Fee Deposit Receipt No. will be reflected in your login (students are advised to keep the original transaction details proof alongwith them and after showing the original transaction details, collect the original fee receipt from accounts deptt by mentioning their fee receipt no. on any working day)
 - (c) After depositing the fee, your registration status will be updated in your ERP Login.
- Hostel registration process: Students can register for hostel accommodation on strictly first-come-first-(iv) served basis. Students must deposit Rupees 25,000/- to get a hostel seat allotted in your name. Actual billing for the room as well as the mess will only be applicable from the day on campus offline classes commence in the campus (after depositing the hostel registration fee, student can follow the above process for issue of hostel fee receipt).
- The fee of the students who would not be promoted to the next academic session by the University due (v) to any reason as per norms, would be adjusted by the Institute in future transactions.
- For campus / Placement activities registration is must for final year students of B.Tech/ M.Tech./ (vi) MBA/MCA courses.
- Time table and links for attending online classes will be e-mailed only to the students who complete the (vii) academic registration process.
- Institute Library is opened on all working days from 10:00 a.m to 04:00 p.m for distribution of books for (viii) the Academic Session : 2020-21
