Round 4- Distribution of awards and prizes on World Consumer Rights Day The winners will be rewarded with a Certificate of Achievement and the Prize money in the following order; 1st prize of INR 10 lacs, 2nd prize of INR 5 lacs, 3rd prize of INR 3 lacs, 4th prize of INR 2 lacs and 5th price of INR 1 lac respectively.

While Round 1 involved registration of participant Teams and Host Institutes, Round 2 will require the participation of your institute/college/industry for organizing Intra Institute DPBH 2023.

For the successful implementation of Round 2, you are requested to kindly ensure your institute/college/industry's participation. We look forward to your active support and participation in the Hackathon as it will be vital in making this program a success and will strengthen the protection of consumer interests. Department believes that together with your support, we can make a significant impact in the fight against dark patterns and enhance the online shopping experience for consumers in India.
