The last date for proposal submission is 15th July 2025. A committee of experts will review the proposals for inclusion in the final agenda.

In addition, institutions are encouraged to nominate M.Tech/PG/Final Year UG students and PhD scholars for participation. The proposed session topics (Annexure I) may be circulated amongst the students and nominate select candidates for participation. A Select number of students will be given the opportunity to attend and engage with the globally acclaimed experts/ speakers.

For the nominated faculty and students for participation (Travel and accommodation to be arranged by the institutions).
